Accordingly, MHR Holdings may be deemed to beneficially own the shares held for the account of Master Account.

(5) These shares are held for the account of MHR Capital Partners (100) LP, a Delaware limited partnership ("Capital Partners (100)"). Advisors is the general partner of Capital Partners (100).
