ITEM 1. SECURITY AND ISSUER.

The security upon which this report is based is the common stock, par value \$0.001, of HALBERD CORPORATION, a Nevada corporation, with its principal place of business located at 10755 Vernon Avenue, Huntington Woods, MI 48070. The telephone number is (248) 530-0270 and the fax number is (248)865-9023.

ITEM 2. IDENTITY AND BACKGROUND.

The name of the person filing this statement is Leland Thomas who is hereinafter sometimes referred to as the "Reporting Person." Leland Thomas who is located at 280 LaSalle Place, Grosse Pointe Farms, MI 48236. The telephone number is (248) 603-6447.

During the past five years, the Reporting Person has not been convicted in a criminal proceeding (excluding traffic violations or similar misdemeanors). In addition, the Reporting Person has not been a party to a civil proceeding of a judicial or administrative body of competent jurisdiction during the last five years which would make it subject to a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, federal or state securities laws or finding any violations with respect to such laws.

The Reporting Person is a citizen of the United States.

ITEM 3. SOURCE AND AMOUNT OF FUNDS OR OTHER CONSIDERATION.

The shares were issued to Leland Thomas as founder shares.

ITEM 4. PURPOSE OF TRANSACTION.

The acquisition of 2,796,000 shares of the Issuer's common stock by the Reporting Person were issued to Leland Thomas as common stock and the shares were valued at par value.

1,100,000 shares are owned by Mr. Thomas directly and 1,696,000 shares are owned through Thomas IRA.

ITEM 5. INTEREST IN SECURITIES OF THE ISSUER.

The Reporting Person acquired 2,796,000 of the issued and outstanding common shares of the Issuer. Such amount represented 10.73 % of the total issued and outstanding common shares of the Issuer.
