(1) The Reporting Person was granted 35,798 shares of Restricted Common Stock under the 2006 Stock-Based Compensation Plan. 13,769 shares vest over a three year period as follows: 4,590 shares on February 25, 2011 and 2012 and 4,589 shares on February 25, 2013. The final 22,029 shares vest on February 25, 2013 based on the Company's Total Shareholder Return versus a defined peer group of companies, with the final number of performance based vested shares varying from 0 to 200% of 22,029.
