(e) Compensation Arrangements

In connection with the 2004 Stock Incentive Plan (the "Plan"), the Company previously granted to Marc Crossman options to purchase common stock of the Company (the "Options") under the Plan pursuant to stock option award agreements dated September 3, 2004; June 13, 2005; and May 12, 2006 (collectively, the "Agreements"). On February 10, 2010, the Compensation Committee of the Board of Directors approved an amendment to the Agreements to permit the exercise of the options on a "net" or "cashless" basis, meaning that: (i) the option holder may elect to exercise the Options by surrendering a portion of the stock options in lieu of paying cash and authorizing the Company withhold a number of shares of common stock that have a Fair Market Value (as defined in the Plan) on the date of exercise equal to the aggregate exercise price due for the number of Options being exercised and (ii) the option holder may elect to satisfy his withholding tax obligations by surrendering a portion of the stock options in lieu of paying cash and authorizing the Company withhold a number of shares of common stock that have a Fair Market Value (as defined in the Plan) on the date of exercise equal to the amount of the taxes which the Company is required to withhold (the "Amendment"). Such shares shall be withheld from the shares of common stock otherwise issuable to the option holder as a result of the exercise of the Options. On February 16, 2010, the Compensation Committee approved the same Amendment for Mr. Joe Dahan with respect to options to purchase common stock of the Company under the Plan pursuant to a stock option award agreement dated August 4, 2005.
