- (1) Restricted Stock Units ("RSUs") were awarded on February 13, 2014, pursuant to the Company's 2009 Long-Term Incentive Plan (the "GMLTIP"). Two-thirds of the RSUs will vest on February 13, 2016 and the remaining one-third will vest on February 13, 2017. Each RSU represents a right to receive one share of the Company's common stock upon settlement. RSUs will be settled when they vest. The Company has determined that 25% of this award will not vest because the terms set forth in the GMLTIP cannot be satisfied.
