The investment management companies, which include a "bank" as defined in Section 3(a)6 of the Securities Exchange Act of 1934 (the "Act") and several investment advisers registered under Section 203 of the Investment Advisers Act of 1940, provide investment advisory and management services for their respective clients which include registered investment companies and institutional accounts. Capital Group International, Inc. does not have investment power or voting power over any of the securities reported herein; however, Capital Group International, Inc. may be deemed to "beneficially own" such securities by virtue of Rule 13d-3 under the Act.

Capital Guardian Trust Company, a bank as defined in Section 3(a)6 of the Act is deemed to be the beneficial owner of 27,836,530 shares or 5.8% of the 482,331,880 shares of Ordinary Shares believed to be outstanding as a result of its serving as the investment manager of various institutional accounts.

Shares reported by Capital Group International, Inc. includes 5,910 shares resulting from the assumed conversion of \$220,000 principal amount of the 4.25% convertible security, due 11-30-04; and includes 144,970 shares resulting from the assumed conversion of \$5,400,000 principal amount of the 4.25% 144A convertible security, due 11-30-04.
