CGII does not have investment power or voting power over any of the securities reported herein. However, by virtue of Rule 13d-3 under the Act, CGII may be deemed to "beneficially own" 4,315,700 shares or 9.8% of the 44,187,000 shares of Common Stock believed to be outstanding.

Capital International, Inc., an investment adviser registered under Section 203 of the Investment Advisers Act of 1940 is deemed to be the beneficial owner of 4,315,700 shares or 9.8% of the 44,187,000 shares of Common Stock believed to be outstanding as a result of acting as investment adviser to various investment companies and institutional accounts.

Emerging Markets Growth Fund, Inc., an investment company registered under the Investment Company Act of 1940, which is advised by Capital International, Inc., is the beneficial owner of 3,133,450 shares or 7.1% of the 44,187,000 shares of Common Stock believed to be outstanding.
